The Nursing Community commends you for supporting a funding level of \$251 million for the Nursing Workforce Development programs (Title VIII of the Public Health Service Act). Thousands of nurses and nursing students of all levels across the country are able to achieve their educational goals with this assistance. We also appreciate the dedicated funding for Nurse Managed Health Clinics (NMHCs) through the Nurse Education, Practice, Quality and Retention program highlighted in report language. The Nursing Community would also like to thank you for supporting a funding level of \$145.2 million for the National Institute of Nursing Research (NINR), one of the 27 institutes and centers comprising the National Institutes of Health. Guided by its mission to improve the health of America's patients in a cost-effective manner, NINR supports research to prevent illness and enhance patient outcomes. Investing in nursing science is crucial to ensuring the continued excellence of nursing care and evidence-based practice.
